1. Objective of the policy

This Privacy Policy describes our policies and procedures on the collection, use and disclosure of your information when you use the services of Intercyte Consulting CC and tells you about your privacy rights and how the law protects you.

We use your personal data to provide and improve our service. By using our Service, you agree to the collection and use of information in accordance with this privacy policy.

2. Definitions

For the purposes of this Privacy Policy:

- Address, Province, ZIP/Postal code, City;
- Usage Data.

3.1.2 Usage Data

Usage Data is collected automatically when using the Service.

Usage Data may include information such as Your Device's Internet Protocol address (e.g. IP address), browser type, browser version, the pages of our Service that you visit, the time and date of your visit, the time spent on those pages, unique device identifiers and other diagnostic data.

4. Use of Your Personal Data


The Company may use Personal Data for the following purposes:
